- g. Costs, Attorneys' Fees, and Expenses. In any legal actions brought in connection with this Agreement, arising out of this Agreement, or arising out of any activity of horse, Boarder, or their guests or agents, the prevailing party will be entitled to prompt payment of expenses from the other party following final adjudication in favor of the prevailing party. For the purpose of this Section, "expenses" will include but not limited to the following costs actually incurred by the prevailing party: attorneys' fees, retainers, court costs, transcript costs, fees of experts, witness fees, travel expenses, duplicating or copying costs, printing and binding costs, telephone charges, postage, delivery service fees, and all other disbursements. Initial:
- 17. Stable's Remedies. If Boarder breaches this Agreement, if horse becomes sick, disabled, injured, or a danger to itself or others, or if Stable ceases to be able to provide services to Boarder and horse hereunder, Stable reserves the right to require Boarder's immediate removal of horse, and to find alternative boarding for horse. If Boarder fails to do so, Boarder agrees they will be fully responsible for all alternative boarding charges so incurred.
- **18. Amendments and Modifications.** The parties may amend this Agreement only by a written agreement executed by all parties.
- 19. Notices.
- **a. Notice to Stable.** All notices must be in writing and delivered to Stable at the following address, in a manner which provides proof of delivery:

- **b.** Notice to Boarder. All notices must be in writing and delivered to Boarder at Boarder's address listed above in this agreement, in a manner which provides proof of delivery.
- **20. Assignment or Transfer.** No party may assign or transfer this Agreement without the prior written consent of the other parties.
- **21. Entire Agreement**. This Agreement contains the entire agreement among the parties. Any modifications or additions must be in writing and signed by all parties to the agreement. No oral modifications will be considered part of the Agreement unless reduced to writing and signed by all parties.
- **22.** Comprehension. Each party hereby affirms and acknowledges that they have been given the opportunity to obtain independent legal review by an attorney of their choosing, that they have read this entire Agreement, that it is in plain language, and that they fully understand and appreciate the meaning of each of its terms.
- **23. Governing Law and Venue.** This agreement shall be governed by the laws of the State of Ohio. Any legality and venue for resolution of disputes shall be filed and held in Lake County, Ohio court.
- **24. Right of Lien.** Boarder is put on notice that Stable has and may assert and exercise a right of lien, as provided for by the laws of the State of Ohio for any amount due for the board and keep of horse(s), and also for any storage or other charges due hereunder, and further agrees Stable shall have the right, without process of law, to attach a lien to your horse(s) after two (2) months of non-payment or partial payment and Stable can then sell horse(s) to recover its loss. Initials:
- 25. Stable Rules. Boarder hereby acknowledges receipt and understanding of the current Stable Rules, which are incorporated by reference in full, as if fully set forth herein. Boarder agrees he/she and his/her guests and invitees will be bound and abide by these Rules, and accepts responsibility for the conduct of his guests and invitees according to these Rules. Boarder acknowledges the Rules include but are not limited to:
 - a. No smoking, no alcohol consumption, and no pets on Bristol Knight Farms premises.

- **b.** All Boarders, Guests, Agents, Visitors must sign a liability waiver / hold harmless agreement.
- c. Be aware of the location of fire extinguishers and the "Emergency Turnout Plan".
- **d.** No person shall handle or ride a horse under the influence of any intoxicating substance.
- e. All horses will wear a halter in pastures and when being moved.
- **f.** Everyone will clean up after themselves and their horse, everywhere..
- **g.** If you find a gate open, close it behind you.
- **h.** No unaccompanied children under 15 in the barn; keep children under control for everyone's safety.
- i. No borrowing anything without the owner's permission.
- **j.** No food (hay, grain, carrots, etc.) or water in arenas.
- **k.** No use of items in the refrigerator unless it is something you brought or you have the owner's permission.
- 1. Only farm management can operate tractors or any other powered equipment.
- m. Follow all instructions from ranch management.
- **n.** Everyone is required to wear an ASTM/SEI approved helmet when mounted on a horse for pleasure and instruction. The only exception is when working on liberty or groundwork.
- **o.** No horses are to be turned out in arenas, unless authorized my management.
- **p.** Long pants and closed-toe shoes must be worn for riding.
- **q.** Do not give treats to horses other than your own, unless approved by the horse owner.
- **r.** Turn off the lights in the arena/barn, close barn doors, and secure entrance gate if you are the last person in the area.
- s. Lessons being conducted by our trainers have priority and right of way in the indoor arena and outdoor rings. Riders not in the lesson may be asked to "pull over" and wait in a safe area while students are jumping courses. If there is ever a question of control and safety, the trainer has the right to ask riders to use only a designated portion of the arena or to leave the arena until the lesson is finished.

Stable may revise these Rules from time to time and Boarder agrees any revision shall have the same force and effect as current Rules. Failure, as determined in Stable's sole discretion, of Boarder or Boarder's guests and invitees to abide by Stable Rules may result in Stable declaring Boarder in default hereunder and result in termination of this Agreement.
