**WAIVER AND RELEASE OF ALL CLAIMS AND ASSUMPTION OF RISK**

Please read this form carefully and be aware that by participating in equine activities, including, but not limited to, spectating, trail riding, riding instruction, traveling to/from and on property, caring for equines, volunteering, and/or recreational riding, you are expressly assuming the risk and legal liability and waiving and releasing all claims for injuries, damages or loss which you might sustain as a result of participating in any and all activities on BKF Equine Solutions, LLC DBA Bristol Knight Farms premises.

You acknowledge that, pursuant to R.C. 2305.321, by participating in equine activities, including but not limited to, spectating, trail riding, riding instruction, traveling to/from and on property, caring for equines, volunteering, and/or recreational riding, you are an equine activity participant. As an equine activity participant, you are subject to the inherent risk of an equine activity as defined in R.C. 2305.321 as a danger or condition that is an integral part of an equine activity, including, but not limited to, any of the following:

1. The propensity of an equine to behave in ways that may result in injury, death, or loss to persons on or around the equine;
2. The unpredictability of an equine's reaction to sounds, sudden movement, unfamiliar objects, persons, or other animals;
3. Hazards, including, but not limited to, surface or subsurface conditions;
4. A collision with another equine, another animal, a person, or an object;
5. The potential of an equine activity participant to act in a negligent manner that may contribute to injury, death, or loss to the person of the participant or to other persons, including, but not limited to, failing to maintain control over an equine or failing to act within the ability of the participant.

You voluntarily agree to assume the full risk of any and all injuries, damages or loss, regardless of severity, that you and/or your minor child/ward may sustain as a result of said participation. You further agree to waive and relinquish all claims you and/or your minor child/ward may have (or that may accrue to you and/or your child/ward) as a result of participating in equine activities against BKF Equine Solutions, LLC DBA Bristol Knight Farms including BKF Equine Solutions, LLC DBA Bristol Knight Farms' board, officers, agents, employees, sponsors, investors, financiers, insurers, representatives (including staff/volunteers), independent contractors, successors, and assigns. You agree to fully release, hold harmless, and indemnify BKF, its board, officers, agents, employees, sponsors, representatives (including staff/volunteers), independent contractors, successors, and assigns from all claims or liabilities of any kind arising out of your participation (and/or your child/ward's participation) in this activity, even though liability may arise out of negligence or carelessness on the part of the persons named in this waiver.
